3. Product Information

5. Shipping

Order processing and Shipment

All orders will be processed the next working day. All shipments have a track and trace code that will be provided to the customer by email. In addition, all shipments are insured against loss and damage until the moment of delivery. As we enter into an insured shipping contract with the carrier, the risks and perils pass on to you ,the receiver, as soon as we hand over the package to the carrier.

Shipping costs

The standard shipping costs in Europe amount to €25.00. Shipping costs to the rest of the world are €45.00.
